## GLOBAL AMR R&D HUB: Work Plan 2018-2021

#### **Vision**

The main goal of the GLOBAL AMR R&D HUB is to promote high-level coordination among governments and upstream funders from different world regions, in order to better align national and international R&D efforts in the fight against AMR.

For that, two main lines of activities have been identified for the work plan, namely:

- (1) Building on existing mapping exercises and other relevant information in form of a "metamapping", to develop a close to real-time Dynamic Dashboard providing information and analysis at a high level on current R&D-related global or regional or national initiatives, R&D funding flows and R&D activities in the field of AMR; and
- (2) Defining the main operational activities and procedures for the GLOBAL AMR R&D HUB.

This work plan covers a timeframe of three years of operation, focussing mainly on concrete operational activities for the first year. The work plan may be adapted, in order to respond to the rapidly evolving field of AMR. The work plan has been established in consultation with a selected set of stakeholders.

## 1 Development of a Dynamic Dashboard

#### **Rationale**

The central deliverable of the GLOBAL AMR R&D HUB will be a close to real-time Dynamic Dashboard providing information and analysis at a high level on current initiatives, funding flows and activities in the field of AMR R&D. The information will be analysed and shall inform policy makers in their decision making on strategic investments and actions in AMR R&D.

This information will be publicly available. A prerequisite for achieving this goal is to have a full picture of the AMR R&D landscape, including all available mappings shared by other contributing organisations (such as WHO and others) that are actively working to combat AMR.

The Dynamic Dashboard should reflect the One Health approach and should comprise information relating to human and animal health as well as environmental aspects. This should be further developed in cooperation with relevant stakeholders such as FAO, OIE and UNEP.

It should comprise information from the public and private sectors on the complete chain of research and development for new antimicrobials and alternatives, diagnostics, and prevention measures/technologies including vaccines, and include push and pull incentives. In order to be able to show early success and to address a high medical need, the Dynamic Dashboard will initially focus on the pipeline of new products against human bacterial infections. Once the Dynamic Dashboard is established, it will be extended in order to address the complete scope of the GLOBAL AMR R&D HUB. It will be a continuous task to keep the Dynamic Dashboard up to date and establish and maintain the relationship with organisations that are the source of various mapping data, in order to keep the information current and accurate without duplicating efforts in mapping data collection and management. Special attention will be given to data quality, consistency and comparability.

The Dynamic Dashboard will use and link to existing sources of information such as the WHO global observatory on health R&D and the R&D pipeline data contained therein. By using a wide

variety of data sources and by filling the gaps between them, the dashboard shall strive to show a comprehensive picture of the global R&D efforts in the fight against AMR.

By gathering information on funding flows, the Hub will help inform the monitoring of the Global Action Plan on AMR.
